Natural Health Product 2017 Report on Compliance Monitoring Posted

The 2017 CMP Report was posted on Health Canada's website on February 1st, 2018. Health Canada took a risk-based and complaint driven approach to this post-marketed activity for NHPs as a proactive tool to balance the current paper-based licensing process. This process utilized a series of planned, on-site visits to NHP facilities. Many companies used these visits as a chance to clarify the requirements to follow them better.

Cosmetics Alliance advocated to Health Canada on three fronts:

- Consolidation of what they found into a separate section un-linked to the inspected facilities,
- Top-level identified issues and actions linked to inspected facilities,
- Giving heads up to each establishment regarding details of the posting prior to posting, being consistent with other CMPs across Health Canada

Consultation for Transportation of Dangerous Goods Client Identification Database

Transports Canada is inviting stakeholders to participate in consultations regarding a new Transportation of Dangerous Goods (TDG) Client Identification Database (CID). Transports Canada is proposing to introduce a new requirement for businesses involved in the importing, offering for transport, handling, and transport of dangerous goods to identify themselves and provide basic information on their dangerous goods activities.

Environmental Update

Publication of the Draft Screening Assessment and the Risk Management Scope for Cyanides

On February 10, 2018 a <u>notice</u> with respect to the screening assessment and the risk management scopes was published in the Canada Gazette. <u>Ten cyanide substances</u> were identified as priorities for assessments as they met categorisation under CEPA. One significant substance to the personal care industry is Tetrasodium ferrocyanide (CAS RN 13601-19-9) and its dehydrate. Tetrasodium ferrocyanide is listed in the NHPID as a non-medicinal ingredient. Cosmetics Alliance will not be commenting on the 60-day consultation unless indicated by members.
