Health Canada - Guidance on the Application of Human Factors to Consumer Products

Health Canada and the United States Consumer Product Safety Commission (CPSC) have drafted a Guidance on the Application of Human Factors to Consumer Products with the goal of helping industry make safer consumer products. Please note this draft guidance document is not a rule and does not establish legally enforceable responsibilities. Health Canada is inviting industry stakeholders, designers and manufacturers in the consumer product sector to consult the guidance document and provide feedback and comments between March 23 to May 14, 2018. Consumer Products and Cosmetics Reports Quarterly Data

Mandatory reports on consumer products received from industry under the Canada Consumer Product Safety Act (CCPSA) from July 1, 2017 to September 30, 2017 is now <u>available</u>. A total of 649 reports were received by Health Canada with 284 reports include an injury. The top three injuries were irritation /allergies, cuts and burns. There were total of 59 reports for cosmetics and is in the top 5 products types for reports received.

Regulatory Transparency and Openness Framework and Action Plan Annual Report

On March 27, 2018 Health Canada released it <u>Regulatory Transparency and Openness</u> <u>Framework and Action Plan (RTOF) Annual Report</u>, which reports on accomplishments achieved in 2016-17 under the RTOF. Industry survey for the Transportation of Dangerous Goods Client Identification Database

Transports Canada held an in-person consultation session from March 15- 23, 2018 on the proposal to introduce a new requirement or businesses involved in the importing, offering for transport, handling and transport of dangerous goods to identify themselves and provide basic information on their dangerous goods activities. This proposal is called the Transportation of Dangerous Goods Client Identification Database (TDG CID). The survey for TDG CID is available till April 5, 2018. ### **Environment Update**

Health Canada's CMP Assessment on Essential Oils

Cosmetics Alliance was approached by Health Canada to help them refine the exposure assessment they are contemplating regarding a group of 15 Essential Oils they are evaluating under the Canadian Chemicals Management Plan (CMP). This is a first of a series of assessments they are conducting under the Terpenes/Terpenoids and Essential Oils grouping under CMP. Of the 15 Essential Oils being assessed, 6 are known to be contained in cosmetics, based on Health Canada's Review of their Cosmetic Notification System (CNS).

## Essential Oil Reporting Template

Notice of Intent - Closure of nominations to the Revised In Commerce List (R-ICL)

As part of the Canada's Chemicals Management Plan, substances on the R-ICL underwent a risk-based prioritization process to identify substances that require further consideration. Creating a static list will allow the prioritization of substances on the R-ICL to be finalized. A Notice of Intent announcing the closure of the nomination of substances on the R-ICL, one year from the date of publication, is scheduled to be published in Canada Gazette Part I on April 7, 2018 with a 60-day comment period. Stakeholders may continue to nominate eligible substances to the R-ICL until the termination date.

#### Draft Screening Assessment of Epoxy Resin

On March 24, 2018 the draft screening assessment of four substances in the <a href="Epoxy Resins">Epoxy Resins</a> Group was published. The four substances are DGEBA Epoxy Resin (CASRN 25036-25-3), DGEBA epoxy resin (CARN 25068-38-6), DGEBA Epoxy Resin (CASRN 25085-99-8), Novolac Epoxy Resin (CASRN 28064-14-4). Epoxy Resin can be found in adhesives particularly is nail polishes and eye lash glue. Cosmetics Alliance encourages any stakeholder affected by the draft screening assessment to comment on the 60-day comment period ending May 23, 2018.
