Health Updates

Health Canada's Access to Information Request – Consumer Health Products Framework

Health Canada received an Access to Information (ATI) request pertaining to the initial consultation on the Consumer Health Products Framework (2015). Health Canada has approached Cosmetics Alliance to seek permission to release in its entirety the extensive consultation response we provided entitled <u>Health Canada Public Consultation on the Proposed</u> <u>Consumer Health Products Framework</u> as filed February 26, 2015, in addition to related correspondence to these initial regulatory reform proposals.

Given the generic nature of the ATI request, we expect that any of our members whom engaged independently with this initial consultation and submitted comments of their own would have or will be receiving a similar package from Health Canada seeking permission to release your input in their response to this request. In preparing our response to this request, we would like to identify and confirm how many of our members have received similar requests.

 - What components of your response are you looking not to disclose?
