Latest News on Dyes of the Aromatic Azo and Benzidine-based Substance Grouping

As part of the Chemicals Management Plan (CMP) the Government of Canada completed screening assessment of 358 <u>Aromatic Azo Benzidine-based substances</u> to assess whether they may pose a danger to human health or the environment. One of the substances assessed was acetamide, N-[4-[(2-hydroxy-5-methylphenyl) azo] phenyl]-, also known as Disperse Yellow 3 or Solvent Yellow 77.

The <u>screening assessment</u> concluded that Disperse Yellow 3 met the environmental criterion for a toxic substance as defined in CEPA. Therefore, the Government is adding the substance to the List of Toxic Substances to Schedule 1 of CEPA.

Calcium 2-ethylhexanoate and 2-ethylhexyl-2-ethylhexanoate Added to Schedule 1 of CEPA

On March 2, 2019 publication of a proposed order adding 2-ethylhexyl-2-ethylhexanoate as added to Schedule 1 of CEPA which was published in the <u>Canada Gazette Part 1</u>. Calcium 2-ethylhexanoate is not considered to be CEPA toxic.

The Government of Canada completed a <u>screening assessment</u> of 2-ethylhexyl 2-ethylhexanoate to determine whether the substance may pose a risk to the environment or human health. The screening assessment determined that the substance does not pose a risk to the environment but may pose a risk to human health and therefore meets the criterion for a toxic substance as set out in CEPA. As result the substance is being added to schedule 1 of CEPA.

Fees Adjustment for the New Substances Program

Environment and Climate Change Canada (ECCC) will adjust fees annually for notification of new substances filed under the <u>New Substances Notification Regulations</u> (Chemicals and Polymers). Fees will be increased by 2.2% as of April 1, 2019.

ECCC is implementing this fee adjustment for the New Substances Program to be in compliance with Canada's Service Fees Act which requires annual fee adjustments based on

the country's Consumer Price Index (CPI) – specifically the previous year's April All-Items CPI. This change applies to all federal service fees.

Moving forward, the New Substances Notification fees will increase every April 1st based on the previous year's April All-Items CPI. The program anticipates informing stakeholders of the new fees early in each calendar year. The notification fees associated with these regulations depend on the type of assessment or service requested, as well as the annual sales of the notifier. Lower annual sales correspond to lower fees.

The New Substances Notification Regulations require any person (individual or company) proposing to import or manufacture a substance that is new to Canada and meets the quantity threshold, to submit prescribed information to the Government of Canada.

Register Now for Ontario MHSW Wind Up Plan Consultation - April 2, 2019

A Steward-focused consultation will take place Tuesday, April 2, 2019, 10:00 - 12:00 p.m. EST. <u>Click here to register</u>.

On April 12, 2018, the Ontario Minister of the Environment and Climate Change issued direction to Stewardship Ontario to wind up the Municipal Hazardous or Special Waste (MHSW) Program by December 31, 2020. Upon wind up, materials collected under the MHSW Program will be managed according to an individual producer responsibility framework under the *Resource Recovery and Circular Economy Act, 2016.* On December 11, 2018, the Minister of the Environment, Conservation and Parks amended the timelines for the wind up of single-use batteries to June 30, 2020. These letters can be found on the MHSW Wind Up web page. In his direction letter, the Minister requires Stewardship Ontario to submit its proposed MHSW Wind Up Plan to the Resource Productivity and Recovery Authority (the Authority) by June 30, 2019. The Minister anticipates that the Authority will approve the plan no later than December 31, 2019.

Stewardship Ontario is committed to operating the MHSW program without disruption until the wind up date, while delivering transparent communication and meaningful consultations with its stakeholders throughout the process. During the consultation webinar, Stewardship Ontario will review the key objectives for winding up the MHSW program, the proposed transition approach, financing and budget considerations, key dates and other elements. Presentations will be about an hour with plenty of time for Q&A. Webinar recordings, presentations and other meeting materials will be made available on the MHSW Wind Up web page.
