Health Update

Amendments to the Cosmetic Ingredient Hotlist – Cannabis

Items Added

Cannabis, as defined in subsection 2(1) of the Cannabis Act (see the Cannabis Exemption (Food and Drugs Act) Regulations for details)

This entry was added to the <u>list of prohibited substances</u> as result of the coming into force of the <u>Cannabis Act</u>. Previously, cannabis was subject to the <u>Controlled Drugs and Substances Act</u>, and these ingredients were prohibited under the Narcotics, natural and synthetic entry. Products containing these ingredients are exempted from the application of the Food and Drugs Act as a result of the Cannabis Exemption (Food and Drugs Act) Regulations.

Items Amended

Cannabis sativa seed oil and Hydrolyzed Hemp seed protein

These entries were combined into a single, broadened entry to better reflect the requirements of the <u>Industrial Hemp Regulations</u>: Cannabis spp. (hemp) derivatives or a product made from those derivatives that are exempt from the application of the Cannabis Act under the Industrial Hemp Regulations on the <u>restricted substances list</u>.

Hydroquinone Information Update

Health Canada has extended the coming into force date of the prescription status of Hydroquinone to June 30, 2019, in order for products to remain available to those who require them. This is a reminder to Canadians of the risk associated with skin-lightening products that contain hydroquinone at concentrations greater than 2%. Products containing high concentrations of hydroquinone should be used with caution and only under the supervision of a health care professional.

Consumer Product Safety and Cosmetics Report

Consumer Product and Safety Directorate released its <u>Consumer Product Safety and Cosmetics Report Quarterly Data</u> from April 1, 2018 to June 30, 2018. In total there were 30 cosmetic related reports out of 620 reports received. The top three injuries out of these 620 reports were irritations, injuries and burns.

Organizational Changes with the Office of Submission and Intellectual Property

Effective October 1, 2018 the Therapeutic Products Directorate's (TPD) Office of Submissions and Intellectual Property (OSIP) will be joining the Resource Management and Operations Directorate (RMOD).

This change will not affect how you submit information to us. Please continue to send submissions to the same address.

The OSIP team will continue to be led by current director, Anne Bowes. The duties carried out by OSIP specific to TPD will remain within TPD. Information dissemination and information management will move to TPD's Office of Planning, Performance and Review Services. The review of administrative submissions will move to the labelling area of TPD's Bureau of Gastroenterology, Infection, and Viral Diseases. All other units and divisions will stay within OSIP as part of RMOD.

Environmental Updates

Final Screening Assessment for Acrylates and Methacrylates Group

On September 29, The Government of Canada released the <u>final screening assessment</u> of <u>Acrylates and Methacrylates Group</u>. There are six substances that are part of the screening assessment which are listed below. These substances were identified for action under the Chemicals Management Plan (CMP). These six substances were identified as priorities for assessment, as they met categorization criteria under subsection 73 of CEPA. It is concluded that acrylic acid, methacrylic acid, n-butyl methacrylate, 2-ethylhexyl acrylate, butyl acrylate and isobornyl methacrylate do not meet any of the criteria set out in section 64 of CEPA.
